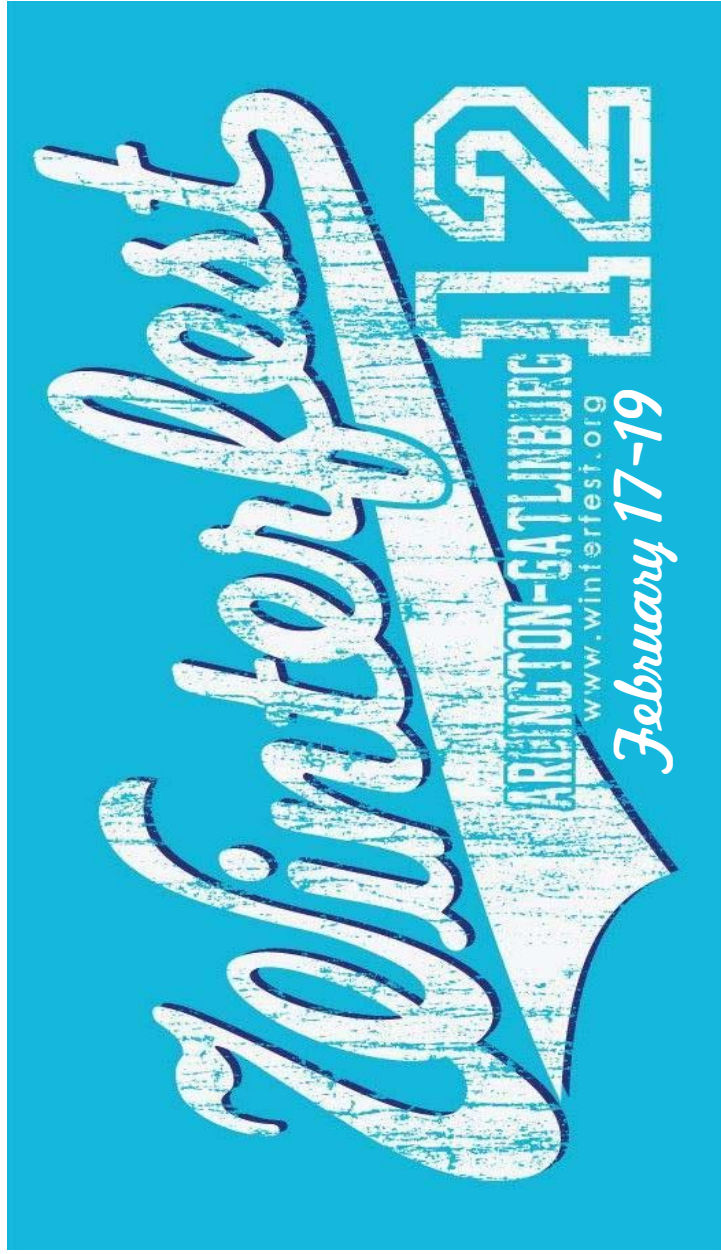
I authorize the Trip Leader to secure medical or surgical treatment as recommended by a physician for the applicant's well being.

## DETAILS AND INFORMATION

**WHEN:** February 17, 18, and 19, 2012

**WHERE:** Winterfest will be held at the Gatlinburg Convention Center. We will be staying at the Edgewater Hotel.

**LEAVING:** We will leave from College Hills on board chartered buses at 11:30 AM Friday, February 17. If it is not possible for you to leave at that time, we could possibly arrange for a later departure time for a small group. If you need this special accommodation, see Johnny.

**RETURNING:** 5:00 PM Sunday, February 19 to College Hills.

**COST:** \$130 for lodging and program fees. Attach this amount to your Registration Form. You will also need to bring money for 4 meals. (Friday supper, Saturday lunch, dinner; Sunday lunch.) Depending on how much you eat, \$45.00 should be enough. The hotel features a complimentary continental breakfast. Eat lunch before coming on Friday.
